


1. The ASSIGNOR agrees to assign United Kingdom Trade Mark Registration No. 2153950 TERAPORT and United States Trade Mark Registration No. 2538769 TERAPORT ("The Trade Mark Registrations") to the ASSIGNEE by executing the Assignment attached hereto as Schedule A ("The Second Assignment") at the same time as this agreement.
2. The ASSIGNOR has provided to the ASSIGNEE a copy and a redacted copy of an Assignment of the Trade Mark Registrations from Power X Limited to the ASSIGNOR dated 29.07.02 ("The First Assignment"). The redacted copy is attached to the Second Assignment. The ASSIGNEE accepts the copy and the redacted copy of the First Assignment as the only documents relating to the assignment from Power X Limited to the ASSIGNOR which it is to receive from the ASSIGNOR.
3. The ASSIGNEE agrees to use only the redacted copy of the First Assignment in recordal of the First Assignment. The ASSIGNEE agrees not to disclose non-redacted copy of the First Assignment to third parties.
4. After execution of this agreement and the Assignment the ASSIGNOR will have no further obligations towards the ASSIGNEE except for signature on behalf of the ASSIGNOR of any documents necessary to effect recordal of the Second Assignment. In particular, the ASSIGNEE agrees to raise no claim against the ASSIGNOR if it does not prove possible to record the First Assignment or the Second Assignment and to raise no claim that the ASSIGNOR is not the true owner of the Trade Mark Registrations.
