ASSIGNMENT

WHEREAS, NORTH AMERICAN AUDIO MANAGEMENT, INC., a New Jersey corporation, having a principal place of business at 85 Kinderkamack Road, Emerson, New Jersey 07630, is the owner of all right, title and interest in and to Trademark Registration Nos. 2,309,271 for the word mark MTS, having a registration date of January 18, 2000, and 2,403,354 for the word mark MILLENNIUM THEATER SYSTEM, having a registration date of November 14, 2000 (collectively the "Property"), pursuant to an assignment ("Assignment") from INTERACTIVE ISLAND SUPPLIES, INC., a New York corporation, having a former principal place of business at 100 C, East Jefryn Boulevard, Deep Park, New York, which is dissolved, to NORTH AMERICAN AUDIO MANAGEMENT, INC.,

WHEREAS, on December 12, 2005, the Assignment was recorded with the United States Patent and Trademark Office at reel 3238 and frame 0938;

WHEREAS, NORTH AMERICAN AUDIO MANAGEMENT, INC., is desirous of acquiring from JOSEPH FULLER (hereinafter "Assignor"), all of his alleged right, title and interest in and to the Property, together with the good will appurtenant thereto and symbolized thereby, that he asserts that he has in and to the Property, if any; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, and intending to be legally bound hereby, said Assignor does hereby assign, sell, transfer, set over and quit claim unto said Assignee the full extent of his right, title and interest in and to the Property, if any, and all registrations therefor, together with all the good will of the business symbolized by the Property, including all the rights Assignor has to sue for and collect damages and other recoveries for past infringement thereof.

And for the consideration aforesaid, Assignor agrees that he will, upon request, execute and deliver to Assignee any and all additional papers and generally do all other and further lawful acts deemed necessary by said Assignee to carry out the terms of this Agreement.
