CONFIRMATORY ASSIGNMENT

WHEREAS, effective December 30, 2005 assets of SOLVOX MFG. COMPANY, then a Wisconsin corporation with a registered office at 300 North Patrick Boulevard, Brookfield, Wisconsin 53045 ("Solvox"), were assigned to HYDRITE CHEMICAL CO., a Wisconsin corporation with a principal office at 300 North Patrick Boulevard, Brookfield, Wisconsin 53045 ("Hydrite"), and Solvox was dissolved as a corporation;

AND WHEREAS, certain of the assets that were assigned in this manner included U.S. trademark registration 1,046,163, which issued on August 10, 1976 and was for the mark "SOLVOX" (the "Registration"), together with the goodwill appurtenant thereto;

AND WHEREAS, Solvox wishes to confirm various aspects of that assignment in a form suitable for recordation at the United States Trademark Office;

NOW THEREFORE, Solvox hereby confirms that it assigned and transferred to Hydrite effective December 30, 2005 its rights in and to the trade name "Solvox Mfg. Company", and the trademark SOLVOX, regardless of whether such rights derived from statutory or common law, or U.S. or foreign sources, together with all SOLVOX-related registrations owned by Solvox (including without limitation the aforesaid Registration), together with all goodwill Solvox owned appurtenant thereto.
