OF KNIGHT MARKETING CORPORATION  
UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

1. The name of this Corporation is Knight Marketing Corporation.
2. The Corporation was originally formed under the name Hobson Oil Company, Inc. pursuant to a Certificate of Incorporation filed with the Department of State on January 6, 1921. The name of said corporation was changed to Knight Oil Corporation by Certificate of Change of Name filed with the Department of State on December 17, 1926. Pursuant to a Certificate of Merger filed with the Department of State on December 1, 1995, Knight Oil Corporation was the surviving corporation and Knight Marketing Corporation, for which a Certificate of Incorporation was filed with the Department of State on January 11, 1980, was one of the constituent corporations merged into Knight Oil Corporation. The Certificate of Merger included a change and amendment to the Certificate of Incorporation of Knight Oil Corporation changing the name of Knight Oil Corporation to Knight Marketing Corporation and restating its Certificate of Incorporation.
3. The purpose of this Amendment is to amend Paragraph 1 of the ~~Restated~~ <sup>W.P.</sup> Certificate of Incorporation of Knight Marketing Corporation to change the name of the corporation to Spray Nine Corporation.  
*1. The name of the Corporation is; Spray Nine Corporation. W.P.*
4. The foregoing Amendment to the ~~Restated~~ <sup>W.P.</sup> Certificate of Incorporation of Knight Marketing Corporation was authorized by a unanimous vote of the holders of all of the outstanding shares of the corporation and all of the Directors of the corporation at a combined shareholders and directors meeting held on the 10th day of December, 2001.
