NOW, THEREFORE, in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, all right, title and interest in the United States and its territories in and to the Trademark and the Logos, together with (i) the goodwill of the business symbolized by the Trademark and the Logos, (ii) all causes of action, claims and demands or other rights for, or arising from any infringement, including past infringement, of the Trademark or the Logos in the Territory and (iii) all rights corresponding thereto throughout the Territory, all upon the terms and subject to the conditions set forth in the Asset Purchase Agreement of even date herewith by and between MGI GP, Inc. and Assignee.

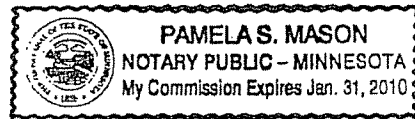
