## ASSIGNMENT OF TRADEMARKS

WHEREAS, Argosy Gaming Company, a Delaware corporation, having a business address of 825 Berkshire Boulevard, Suite 200, Wyomissing, Pennsylvania ("Argosy"), is the owner the trademarks listed on Exhibit A attached hereto (the "Marks");

WHEREAS, Argosy, CP Baton Rouge Casino, L.L.C., a Louisiana limited liability company ("Buyer"), and Wimar Tahoe Corporation, a Nevada corporation and the parent company of Buyer made and entered into as of October 3, 2005 that certain Securities Purchase Agreement (the "Purchase Agreement");

WHEREAS, pursuant to the Purchase Agreement, Buyer acquired the Argosy Casino-Baton Rouge gaming facility located in Baton Rouge, Louisiana ("ACBR");

WHEREAS, the Marks have been used by the ACBR, in the conduct of its casino and gaming business;

WHEREAS, the Buyer desires to acquire all rights, title and interest in and to the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound hereby, Argosy hereby irrevocably assigns, sells, conveys, transfers and delivers to Buyer all rights, title and interest in and to the Marks, and the goodwill of the business associated therewith.

Argosy agrees not to make any further use of the Marks after the date of the assignment.

Argosy agrees to execute and deliver such other instruments of sale, transfer, conveyance, assignment and confirmation and take such other action as may reasonably be necessary to confirm Buyer's title to the Marks after the date of assignment with any authority with which the Marks has been registered.
