2. The Certificate of Incorporation for NATIONAL TRADE PUBLICATIONS, INC., was filed by the Department of State on March 20, 1981, and amended on December 28, 1995.
3. Paragraph First of the Certificate of Incorporation, which sets forth the name of the Corporation, is hereby amended to read:

**FIRST:** The name of the Corporation is NTP MEDIA, INC.

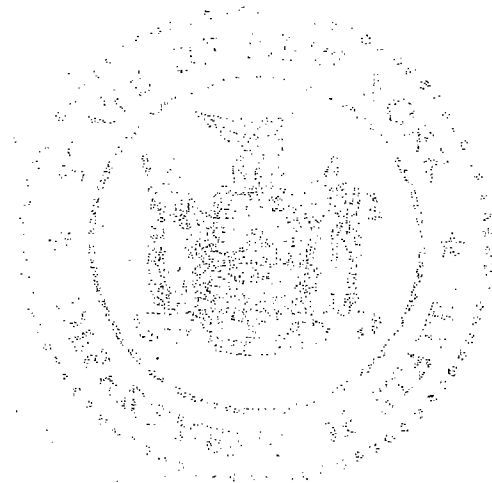
