ASSIGNMENT OF TRADEMARKS


WHEREAS, Teneros, Inc., a corporation organized and existing under the laws of the state of California, with a principal place of business located at 215 Castro Street, Third Floor, Mountain View, CA 94091, (hereinafter referred to as "Assignor") is the owner of the entire right, title and interest in and to the trademarks and trademark applications identified on Schedule A attached hereto together with the goodwill (if any) related thereto (hereinafter collectively referred to as the "Marks"); and



NOW THEREFORE, in consideration of the foregoing, as well as other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks, together with the business and goodwill of the business (if any) in connection with which the aforesaid Marks have been used, and all claims, if any, which may have arisen thereunder prior to the date of this instrument.


