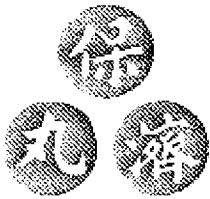

WHEREAS, it has come to the attention of LCST and POP that there are sources unknown to POP and LCST providing the alleged Product to various retailers, and


