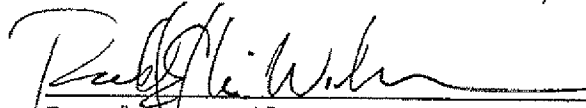
2. Immediately prior to the filing of these Articles of Conversion, the name of the Partnership was VIP Investments, Ltd.

## ARTICLES OF ORGANIZATION OF VIP INVESTMENTS, LLC

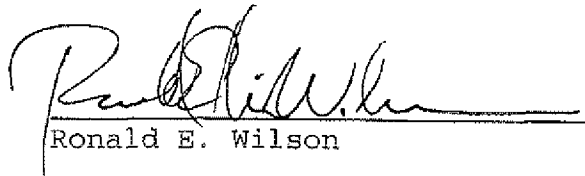
2. The latest date upon which the Company is to be dissolved is December 31, 2100.

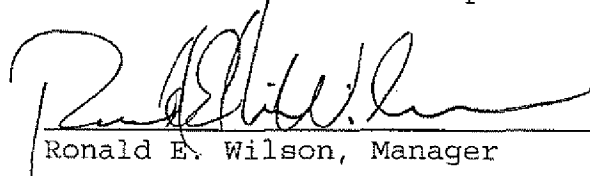
