ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to record the rights to trademarks, registrations, applications and title thereto, to record the right to trademarks and registrations listed in the annexed SCHEDULE OF TRADEMARKS as the property of ASSIGNEE; and \_\_\_\_\_


