ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS, dated September 22, 2006 (this “**Agreement**”), is entered into by Trestle Acquisition Corp., a Delaware corporation (“**Assignor**”), for the benefit of CLRT Acquisition LLC, a Delaware limited liability company (the “**Assignee**”).

WHEREAS, Assignee, Clariant, Inc., a Delaware corporation and sole member of Assignee, Assignor and Trestle Holdings Inc., a Delaware corporation and sole stockholder of Assignor have entered into that certain Asset Purchase Agreement dated as of June 19, 2006 (the “**Purchase Agreement**”).

WHEREAS, Assignor has agreed to sell and assign, and the Assignee has agreed to buy and acquire all of Assignor’s rights, title and interests in and to the trademarks and trademark applications set forth in Exhibit A attached hereto (the “**Assigned Trademarks**”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and conveys to the Assignee and its successors, assigns and other legal representatives, all rights, title and interests worldwide, including common law rights, in and to the Assigned Trademarks, together with the goodwill of the business symbolized by the Assigned Trademarks, and any applications or registrations therefor in the U.S. and throughout the world. This assignment includes the right to sue and recover damages for past and future infringements of Assignor’s rights in the Assigned Trademarks and to bring any proceeding in the United States Patent and Trademark Office or equivalent agency in any other country for cancellation or opposition or other proceeding in connection with the Assigned Trademarks.

Assignor further agrees that, should additional or further documentation of the assignment be required for whatever reason, Assignor will, without further consideration, provide or execute such other information or documents as may be necessary upon the Assignee’s reasonable request.

This Agreement shall be binding on and shall inure to the benefit of, the parties hereto and their respective successors and assigns. This Agreement will be governed by, and construed in accordance with, the internal laws of the State of California applicable to contracts executed and performed entirely therein, without regard to the principles of choice of law or conflicts or law of any jurisdiction. If any term or other provision of this Agreement is invalid, illegal or incapable of being enforced by any rule of law or public policy, all other conditions and provisions of this Agreement will nevertheless remain in full force and effect so long as the economic or legal substance of the transactions contemplated hereby is not affected in any manner materially adverse to any party. Upon such determination that any term or other provision is invalid, illegal or incapable of being enforced, the parties hereto will negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible. This Agreement may be executed in one or more counterparts, and by the different parties hereto in separate counterparts,

each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement.



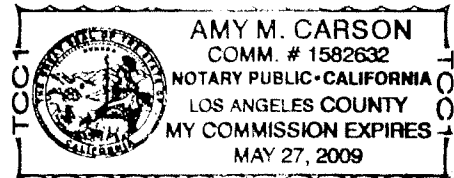
