RELEASE OF TRADEMARK

THIS RELEASE dated as of ~~September 11, 1988~~ and effective as of 9/30/88 ("Release") is made by Bank of America Corporation, a corporation with offices at 111 Massachusetts Avenue, Boston, MA, as the successor in interest to Fleet National Bank, a Massachusetts national banking associate, ("Secured Party") under that certain Security Agreement dated as of March 15, 1989 (the "Agreement"), from Vent Rite Valve Corp. (the "Debtor").

WHEREAS, pursuant to the Agreement and recorded in the records of the United States Patent and Trademark Office on May 16, 1989 at Reel 0651, Frame 0775, from the Debtor to the Secured Party, the Debtor granted to Secured Party, a continuing security interest in the trademark VENT-RITE and registrations therefor, including but not limited to U.S. Registration No. 1,496,688 issued July 19, 1988 (collectively the "Trademark");

WHEREAS, the Secured Party wishes to release all of its interest in the Debtor's Trademark in the records of the United States Patent and Trademark Office;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby release, without any representation or warranty whatsoever, its security interest in and to the Trademark, granted to the Secured Party pursuant to the Agreement, together with the goodwill of the business symbolized by the Trademark and any right, title and interest of the Secured Party in, to and under the Trademark shall hereby cease and become void.

Secured Party shall execute any further documents as may be reasonably requested by the Debtor in order to fully effectuate the release of its security interest in the Debtor's Charged Premises as contemplated herein.

IN WITNESS WHEREOF, the Secured Party has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
