CERTIFICATE OF AMENDMENT
ARTICLES OF INCORPORATION
OF
MACHINE CONTROL TECHNOLOGY, INC.

James B. Barsby and Janice E. Barsby hereby certify:

1. That they are the President and Secretary, respectively, of Machine Control Technology, Inc., a California corporation.

2. Article I of the Articles of Incorporation of this Corporation is amended to read as follows:

"I

The name of this Corporation is Omega Corrugated, Inc."

3. The following provision is added as Article VI of the Articles of Incorporation of this corporation:

"VI

The Corporation's issued shares shall be held of record by not more than thirty-five (35) persons. This Corporation is a close corporation."

4. The following provision is added as Article VII of the Articles of Incorporation of this corporation:

"VII

The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law."

5. The following provision is added as Article VIII of the Articles of Incorporation of this corporation:

"VIII

The corporation is authorized to provide indemnification of agents (as defined in Section 317 of the Corporations Code) for breach of duty to the corporation and its stockholders through by-law provisions or through agreements with the agents, or both, in excess of the indemnification otherwise

permitted by Section 317 of the Corporations Code, subject to the limits on such excess indemnification set forth in Section 204 of the Corporations Code."

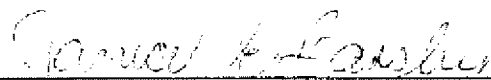
6. The foregoing amendments of Articles of Incorporation have been duly approved by the Board of Directors.

7. The foregoing amendments have been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The Corporation has only one class of shares and the number of outstanding shares is 400. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was 100%.
