
WHEREAS, the Assignor is the owner of all right, title and interest in and to the Trademarks listed on the attached Schedule (hereinafter "the Marks"); and


WHEREAS, Assignor is desirous of assigning, and Assignee is desirous of obtaining, all right, title and interest in and to the Marks.
