## ASSIGNMENT

WHEREAS, Steiner Turf Equipment Rhode Island Inc., a Delaware corporation (hereinafter, "Steiner Rhode Island"), has adopted, used and is using the trademarks described herein, along with the goodwill of Steiner Rhode Island's business symbolized thereby, and is the owner of all right, title, and interest in and to the trademarks described herein, including any and all United States, state or foreign registrations issued, applications filed, common-law rights related to said trademarks, rights to obtain renewals and all other legal protections pertaining thereto;

WHEREAS, Steiner Rhode Island desires to transfer all of its right, title, and interest in such trademarks and goodwill of the business symbolized and associated with such trademarks so acquired to Steiner Turf Equipment, Inc., a Wisconsin corporation (hereinafter, "Steiner");

NOW, THEREFORE, to whom it may concern, be it known that for good and valuable consideration, the receipt of which is hereby mutually acknowledged:

1. THE ASSIGNMENT OF TRADEMARKS AND GOODWILL BY STEINER RHODE ISLAND TO STEINER

Steiner Rhode Island has assigned, and transferred, and by these presents, Steiner Rhode Island hereby does assign, transfer, and deliver to Steiner, its successors, assigns, and legal representatives the whole of any and whatever right, title, and interest Steiner Rhode Island may have in and to: (i) the trademarks listed in Exhibit A hereto, and any United States, state or foreign registrations of such trademarks, applications filed, common-law rights related to said trademarks, rights to obtain renewals and all other legal protections pertaining thereto (hereinafter, the "Trademarks"); and (ii) the goodwill of Steiner Rhode Island's business symbolized by and associated with the trademarks listed in Exhibit A hereto (hereinafter, the "Goodwill").


2. FURTHER ASSURANCES


