ASSIGNMENT OF TRADEMARK

The Director of the United States Patent and Trademark Office and the responsible authorities is also authorized and requested to accept any recordation of assignment for the Trademark(s) and Trademark Application(s) for Y²⁵. **Süd-Chemie, Inc.** also agrees that **Southern Clay Products, Inc.** may apply for foreign Letters Trademarks on

Y²⁵, and Süd-Chemie, Inc. agrees to cooperate with Southern Clay Products, Inc. and execute without additional consideration any additional documents as deemed necessary by Southern Clay Products, Inc., to apply for or maintain trademarks or other legal protection for Y²⁵ in the United States.
