## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of this 19th day of September, 2006 (the "Effective Date"), by Educational Funding of the South, Inc., a Tennessee corporation (the "Assignor") in favor of Edamerica, Inc., a Nevada corporation (the "Assignee").

### **BACKGROUND**

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign to Assignee all right, title and interest in and to the Trademarks, and all goodwill related to or symbolized by such Trademarks; and

WHEREAS, Assignor wishes to execute and deliver this Assignment for the purposes of assigning the Trademarks and all goodwill related to or symbolized by such Trademarks from Assignor to Assignee and recording such assignment with the United States Patent and Trademark Office and any relevant non-U.S. patent and trademark offices.

### **ASSIGNMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby sells, conveys, transfers, assigns and sets over absolutely to the Assignee, and Assignee hereby receives, acquires and accepts, all of Assignor's rights, title and interest in and to the Trademarks and the use of such Trademarks, including without limitation, all of the goodwill associated with or symbolized by the Trademarks, including any registrations, applications, extensions and renewals of the Trademarks, the right to sue for past, present and future infringement of the Trademarks, the right to assume any licenses connected with the Trademarks and the right to any other claim arising out of or relating to the use and ownership of the Trademarks, and all rights corresponding thereto throughout the world. It is expressly acknowledged that with respect to the Trademarks for which registration is being sought in the U.S. under the intent-to-use provision of the Trademark Act (15 U.S.C. §1051(b)), Assignor is assigning those Trademarks as part of the entire business or portion thereof to which those Trademarks pertain.

2. Further Assurances. At any time on or after the date of this Assignment, Assignor agrees to execute and deliver all such further transfers, assignments, conveyances and assurances and take or cause to be taken such actions as may reasonably be requested by the Assignee to obtain the full benefit of this Assignment. Assignor further covenants that Assignee will, upon request and without further consideration, be

provided promptly with all pertinent facts, documents and specimens relating to the Trademarks and all legal equivalents as may be known or accessible to Assignor.

3. Successors and Assigns. This Assignment and all of the provisions hereof shall be binding upon and inure to the benefit of the parties and their respective successors and assigns.

4. Governing Law. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in all respects, including validity, interpretation and effect, in accordance with the laws of the State of Tennessee without giving effect to the principles of conflicts of laws thereof.




