UNITED STATES TRADEMARK ASSIGNMENT

WHEREAS, SHUFFLE MASTER, INC., a corporation organized and existing under the laws of the State of Minnesota, having an office and place of business at 1106 Palms Airport Drive, Las Vegas, NV 89119, hereinafter referred to as “SMI” has adopted and is continuing to use the service mark(s) “TRIPLE SHOT” and “TRIPLE SHOT BONUS”; and

WHEREAS, SMI has registered the marks “TRIPLE SHOT” and “TRIPLE SHOT BONUS” as a service mark on the Principal Registry of the United States Trademark Office, Reg. No. 2,583,718, Reg. Date June 18, 2002; and Reg. No. 2,718,954, Reg. Date May 23, 2003, respectively, for use in entertainment services, namely, providing live casino games in gaming establishments, in International Class 41, such marks currently being in good standing on said Registry; and

WHEREAS, YEHIA A. AWADA, an individual, and a United States citizen, having an office and place of business at 4054 Dean Martin Drive, Las Vegas, NV 89103, hereinafter referred to as “AWADA” is desirous of acquiring the entire right, title and interest in and to the service marks “TRIPLE SHOT” and “TRIPLE SHOT BONUS” and the U.S. Principal Registration thereof, Reg. Nos. 2,583,718 and 2,718,954, respectively, and the good will of the business pertaining thereto; and

WHEREAS, SMI is willing to assign all of its rights, title and interest in and to such marks and to forever terminate any further use of the mark for any purpose;

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, SMI hereby sells, assigns and transfers to Awada, its successors and assigns, the entire right, title and interest in and to the marks “TRIPLE SHOT” and “TRIPLE SHOT BONUS” and the U.S. Principal Registration thereof, Reg. No. 2,583,718 and 2,718,954, respectively, and the good will of the business pertaining thereto.

SMI agrees to immediately terminate and refrain from any further use of the mark for any purpose and to execute such other documents as may be necessary to effectuate and record the assignment of the mark and any rights granted hereby.
