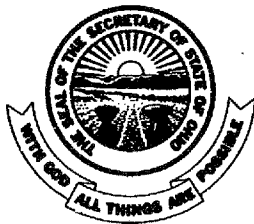

The undersigned officers of Federal Process Company (the "Corporation"), an Ohio corporation, do hereby certify that in a writing signed by all of the shareholders of the Corporation, as permitted by Section 1701.54 of the Ohio Revised Code, the following resolutions to amend the Amended and Restated Articles of Incorporation of the Corporation were adopted effective as of March 31, 1997:

RESOLVED, that Article 1 of the Amended and Restated Articles of Incorporation of Federal Process Company (the "Articles of Incorporation") be and it hereby is amended by deletion of the current text and replacement with new text so as to read in its entirety:

"The name of the corporation is Federal Process Corporation."

RESOLVED FURTHER, that the President of the Corporation and any other corporate officer be and they hereby are authorized and directed to execute and file in the Office of the Secretary of State of Ohio an appropriate Certificate of Amendment to the Articles of Incorporation in order to carry out the intent and purpose of the preceding resolution and render effective said Amendment to the Articles of Incorporation.
