RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of November 3, 2006, is made by Wells Fargo Bank, National Association, as administrative agent (the "Administrative Agent") under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS Pfingsten Publishing, L.L.C., a Delaware limited liability company (the "Borrower") and the Administrative Agent entered into that certain Credit Agreement, dated as of March 12, 2004 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, the various financial institutions and other Persons from time to time parties thereto (collectively, the "Lenders") and the Administrative Agent, pursuant to which Credit Agreement the Lenders and the Issuer have made certain advances and other financial accommodations to and for the benefit of the Borrower;

WHEREAS the Borrower granted security interests in certain property pursuant to the agreements attached as Annex I hereto (collectively, the "Security Agreements"); and

WHEREAS the Security Agreements were recorded in the United States Patent and Trademark Office and United States Copyright Office;

NOW THEREFORE, the Administrative Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the collateral granted pursuant to the Security Agreements, including, without limitation, the collateral listed on the schedules attached to each of the Security Agreements.

The Administrative Agent agrees, at the Borrower's expense, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization necessary to effect the release of the Administrative Agent's security interest in the released collateral described herein.
