

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and deliver to Assignee, its successors, assigns and legal representatives, its full and exclusive right, title and interest in and to the ECONO FENCE Trademark, together with the goodwill of the business symbolized by the Trademark and associated therewith, and all other common law rights and applications and registrations of the Trademark, including U.S. Trademark Registration No. 1,337,991; and the right to recover for damages and profits for past infringements of the Trademark.

This assignment shall be binding upon Assignor's successors, assigns and legal representatives, and shall inure to the benefit of Assignee, its successors, assigns and legal representative, as the case may be.


