ARTICLES OF AMENDMENT

Epilepsy Association of Maryland, Inc., a Maryland non-stock corporation, having its principal office at 300 E. Joppa Road, Suite 1103, Towson, Maryland 21286 (hereinafter referred to as the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland (hereinafter referred to as the "Department") that:

FIRST: The Charter of the Corporation is hereby amended to change the name of the Corporation by striking, in its entirety, Article SECOND and by substituting in lieu thereof, the following:

"SECOND: The name of the Corporation (which is hereinafter called "Corporation") is: Abilities Network, Inc.

SECOND: The Board of Directors of the Corporation, at a meeting duly convened and held on November 17, 1999, adopted a resolution in which was set forth the foregoing amendment to the charter, declaring that the said amendment of the charter was advisable, and that the amendments to the Charter of the Corporation have been duly authorized by the Board of Directors of the nonstock Corporation. There are no voting members of the Corporation other than the Board of Directors of the nonstock corporation.

IN WITNESS WHEREOF, Epilepsy Association of Maryland, Inc. has caused these presents to be signed in its name and on its behalf by its President and its corporate seal to be hereunder affixed and attested by its Secretary on this 27th day of February, 2000 and, as President, acknowledges that these Articles of Amendment are the act and deed of Epilepsy Association of Maryland, Inc., and under the penalties of perjury, that the matters and facts set forth herein, with respect to authorization and approval, are true in all material respects to the best of her knowledge, information and belief.
