TRADEMARK ASSIGNMENT

ASSIGNMENT made this 17th day of October, 2003, by and between Cruz Bay Publishing, Inc., a Delaware corporation having an address at c/o Wind Point Partners, One Towne Square, Suite 780, Southfield, MI 48076 (hereinafter "Assignee"), and Citizens Bank of Massachusetts, a Massachusetts bank having an address at Exchange Place, 53 State Street, 8th Floor, Boston, MA 02109, as agent for Citizens Bank of Massachusetts, MCG Capital Corporation (f/k/a MCG Credit Corporation), and MCG Finance I, LLC (f/k/a MCG Finance Corporation) (in such capacity, hereinafter "Assignor").

WHEREAS, Sabot Publishing, Inc., a Virginia corporation, and its subsidiaries Black Belt Communications, Inc., Better Nutrition, Inc., Vegetarian Times, Inc., Southwest Art, Inc. and Garlinghouse, Inc. (collectively, hereinafter the "Company"), own and have used, are using, or have intended to use in the United States of America the service marks and trademarks described on Schedule A attached hereto (hereinafter the "Marks");

WHEREAS, Assignor is the holder of a security interest in the Marks and the goodwill of the business associated therewith, pursuant to a certain Second Amended and Restated Credit Agreement dated as of June 4, 2001, as amended, by and between, among others, Company and Assignor, as amended; and

WHEREAS, in connection with the terms of a Bill of Sale, of even date herewith, by and among Assignor, MCG Capital Corporation, MCG Finance I, LLC and Assignee (the "Bill of Sale"), Assignee is desirous of acquiring the Marks, the goodwill, and the entirety of the business associated therewith, as well as all federal applications and registrations.

NOW, THEREFORE, it is agreed that pursuant to the purchase of the total business assets of Company's ongoing and existing business to which the Marks pertain, the receipt and

sufficiency of such consideration is hereby acknowledged, Assignor conveys, transfers, and assigns to Assignee, as and to the extent provided in the Bill of Sale, all of Assignor's right, title, and interest in and to the Marks and the federal applications and registrations therefor, together with the goodwill and entirety of the ongoing and existing business symbolized thereby.

Assignor further assigns to Assignee all of Assignor's rights to sue for and receive all damages occurring from past infringing uses of the Marks.

Assignor agrees that upon request by Assignee, as and to the extent provided in the Bill of Sale, Assignor shall execute all papers, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this Assignment at Assignee's expense and request, as well as provide such other material, information, or assistance as Assignee may consider necessary.

This Assignment shall be binding on the parties, their successors and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.
