



majority of the stockholders of the Corporation at the Corporation's 2005 Annual

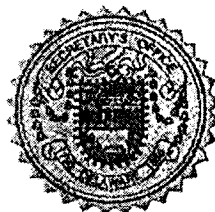
