
WHEREAS, the Company, under Tennyson's license and control, used, and is continuing to use the Trademarks;

WHEREAS, the Company is desirous of acquiring the Trademarks.



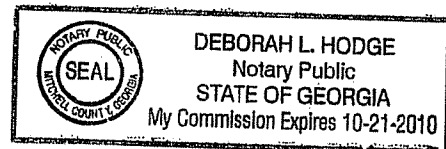
