TRADEMARK ASSIGNMENT

Assignor, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby sell, assign, transfer, convey and set over to Assignee and Assignee's heirs, successors and assigns, as of the Effective Date, for the Assignee's use and benefit, all right, title and interest in and to its Marks, including names, trade names, logos and designs used, or intended to be used, together or separately, whether registerable or not, including, but not limited to, those Marks listed on Exhibit A, attached hereto and incorporated herein, together with goodwill symbolized by said Marks, and also the entire right, title and interest in all benefits, claims, demands and rights or recovery for past, present and future infringement, if any, of said Marks, subject to the terms and conditions of the Merger Agreement between Assignor and Assignee.

Assignor represents that it is the sole and exclusive owner of the Marks and that no part of the Marks have heretofore been pledged, conveyed, or encumbered in any way. Assignor further agrees to execute and deliver, at the request of Assignee, all paper, instruments, and assignments, and to perform any other acts Assignee may require in order to vest all rights, title and interest in and to the Marks in Assignee and/or to provide evidence to support any of the foregoing in the

event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.
