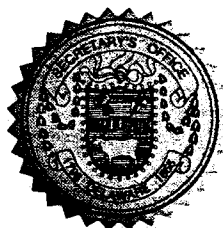

SEVENTH: That the merger will become effective on the date which this Certificate of Merger is filed with the Secretary of State.

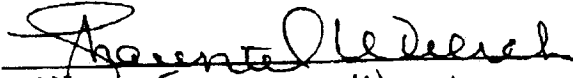
