- 3. The election to become a limited partnership has been approved as required by Section 14-9-206.2(a)(3) of the Act.
- 4. Filed with this Certificate of Election is a Certificate of Limited Partnership in the form required by Section 14-9-201 of the Act that sets forth a name for the limited partnership that satisfies the requirements of Section 14-9-102 of the Act, and such Certificate shall be the certificate of limited partnership of the limited partnership formed pursuant hereto unless and until modified in accordance with the Act.
