**ASSIGNMENT**

WHEREAS, Cadillac Gage Textron Inc., a Michigan corporation (hereinafter "Cadillac Gage"), has adopted, used and is using the trademarks described herein, along with the goodwill of Cadillac Gage's business symbolized thereby, and is the owner of all right, title, and interest in and to the trademarks described herein, including any and all United States, state or foreign registrations issued, applications filed, common-law rights related to said trademarks, rights to obtain renewals and all other legal protections pertaining thereto;

WHEREAS, Cadillac Gage desires to transfer all of its right, title, and interest in and to such trademarks, along with the goodwill of the business symbolized by and associated with such trademarks, to Cadillac Gage Rhode Island Inc., a Delaware corporation (hereinafter "Cadillac Gage Rhode Island");

WHEREAS, all transfers of intellectual property pursuant to this Assignment are intended to be transfers pursuant to Section 351 of the Internal Revenue Code of 1986, as amended (the "Code");

NOW, THEREFORE, to whom it may concern, be it known that for good and valuable consideration, the receipt of which is hereby mutually acknowledged:

1. THE ASSIGNMENT OF TRADEMARK RIGHTS AND THE ASSOCIATED GOODWILL BY CADILLAC GAGE TO CADILLAC GAGE RHODE ISLAND


Cadillac Gage has assigned, and transferred, and by these presents, Cadillac Gage hereby does assign, transfer, and deliver to Cadillac Gage Rhode Island, its successors, assigns, and legal representatives the whole of any and whatever right, title, and interest Cadillac Gage may have in and to: (i) the trademarks listed in Exhibit A, and any United States, state or foreign registrations of such trademarks, applications filed, common-law rights related to said trademarks, rights to obtain renewals and all other legal protections pertaining thereto; and (ii) the goodwill of Cadillac Gage's business symbolized by and associated with the trademarks listed in Exhibit A.

2. FURTHER ASSURANCES


