ASSIGNMENT

WHEREAS, in light of the foregoing, the parties acknowledge that this Assignment is intended to effectuate an assignment by Assignors to Assignee of the rights that Assignors may have, if any, in and to the Samuels Trademarks.


NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby sell, assign and transfer unto Assignee, her successors, assigns and legal representatives, and Assignee hereby accepts the sale, assignment and transfer of, the entire right, title and interest that the Assignors may have, if any, in and to the Samuels Trademarks, including domestic and foreign rights, the same to be held and enjoyed by the Assignee, its successors, assigns and legal representatives from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the Assignors had this Assignment not been made, including without limitation: (i) all goodwill of the entire portion of Assignors' businesses to which the Samuels Trademarks pertain and which is symbolized thereby; (ii) any and all applications and renewals and all registrations or certificates that may be issued or granted for the Samuels Trademarks; (iii) all income, royalties, damages and payments now or hereafter due or payable in respect to the Samuels Trademarks; (iv) all causes of action, either in law or in equity, for damages for past, present or future infringement of the Samuels Trademarks, throughout the entire world; and (v) the right throughout the world to file applications and/or renewals and obtain trademark registrations in the Samuels Trademarks in Assignee's own name throughout the world, including, without limitation, all rights of priority.

All related costs and expenses for the assignment and registration, if any, of the Samuels Trademarks, shall be wholly borne by Assignee.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of Texas without giving effect to the principles of conflicts of laws thereof.


