RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of March 1, 2007, is made by The Royal Bank of Scotland plc, as security trustee (the "Security Trustee") for the Finance Parties and as facility agent (the "Facility Agent") for the Lenders under the Senior Facilities Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Senior Facilities Agreement).

WHEREAS, Tiger III, Inc. (the "Company" and the "Original Guarantor"), the Security Trustee and the Facility Agent entered into that certain Senior Facilities Agreement, dated as of October 4, 2004 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Senior Facilities Agreement"), among the Company, the Original Guarantor, the Facility Agent, the Security Trustee, the various financial institutions party thereto as lenders thereunder (each individually a "Lender", and collectively the "Lenders") and The Royal Bank of Scotland plc in its capacities as mandated lead arranger (the "Mandated Lead Arranger") and issuing bank (the "Issuing Bank"), pursuant to which Senior Facilities Agreement the Lenders made credit extensions to the Company;

WHEREAS, in connection with the Senior Facilities Agreement and pursuant to those certain agreements listed on the Annex I attached hereto (collectively, the "Transaction Security Agreements"), the Company and certain of the Company's Subsidiaries granted security interests in certain intellectual property owned by the Company or such Subsidiary listed on Annex II attached hereto (collectively, the "Patent and Trademark Collateral"); and

WHEREAS, the Patent and Trademark Collateral was recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex II hereto;

NOW THEREFORE, each of the Security Trustee and the Facility Agent hereby RELEASES, without representation, recourse or warranty whatsoever, all of its security interest in the Patent and Trademark Collateral, whether granted pursuant to the Transaction Security Agreements or any other agreement or document delivered in connection with the Senior Facilities Agreement and each of the Security Trustee and the Facility Agent hereby reassigns any and all such right, title and interest (if any) that it may have in the Patent and Trademark Collateral to the Company or its relevant Subsidiary (as the case may be).

The Facility Agent agrees, at the Company's expense, to cooperate with the Company and its Subsidiaries and to provide the Company and its Subsidiaries with the information and additional authorization reasonably required or desirable to effect the release of the Security Trustee's and the Facility Agent's security interests in the released collateral described herein.

Security Agreement between Tumi Holdings, Inc. as Grantor and The Royal Bank of Scotland plc as Security Trustee (in relation to the Agreement and Plan of Merger, dated as of October 4, 2004, made by and among Grantor, Tiger I, Inc., Tiger III, Inc. and OCM principal opportunities fund II, LLP (the "Merger Agreement") dated November 17, 2004.
7. Security Agreement between Tiger I, Inc. (now known as Tumi I, Inc.) as Grantor and The Royal Bank of Scotland plc as Security Trustee (in relation to the Merger Agreement).
8. Mortgage relating to the Georgia freehold property executed by Tumi Inc. as Grantor dated November 17, 2004.
9. Security over Shares Agreement between Tumi, Inc. as Chargor and The Royal Bank of Scotland plc as Security Trustee over its shares in Tumi Asia, Limited dated November 17, 2004.
10. Deposit Account Control Agreement between Tumi, Inc., The Royal Bank of Scotland plc as Security Trustee and Citizens Bank of Pennsylvania dated as of January 12, 2004.
