**CERTIFICATE OF AMENDMENT TO THE
THIRD AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF TV HEAD, INC.**

TV Head, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware DOES HEREBY CERTIFY:

FIRST: The name of the corporation is TV Head, Inc.

SECOND: The original Certificate of Incorporation of the corporation was filed with the Secretary of State of the State of Delaware on May 9, 2003. A Certificate of Amendment was filed in the Office of the Secretary of the State of Delaware on October 24, 2003. The Amended and Restated Certificate of Incorporation was filed in the Office of the Secretary of State of the State of Delaware on June 30, 2004. The Second Amended and Restated Certificate of Incorporation was filed in the Office of the Secretary of State of the State of Delaware on June 10, 2005. A Certificate of Amendment was filed in the Office of the Secretary of State of the State of Delaware on December 22, 2005. The Third Amended and Restated Certificate of Incorporation was filed in the Office of the Secretary of State of the State of Delaware on March 3, 2006.

THIRD: The Certificate of Incorporation of the corporation is hereby amended by deleting the text of Article FIRST in its entirety and substituting the following in lieu thereof:

“The name of this corporation is TAG Networks, Inc. (the “Corporation”).”

FOURTH: The foregoing amendment of the Certificate of Incorporation has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware by the directors and stockholders of the Corporation.
