TRADEMARK RELEASE, effective as of this 28th day of February, 2007, given by MERRILL LYNCH CAPITAL CORPORATION, as Collateral Agent ("Agent") with principal offices at 4 World Financial Center, 16th Floor, New York, NY 10005, to PAETEC COMMUNICATIONS, INC., a Delaware corporation ("Grantor"), with principal offices at One PaeTec Plaza, 600 Willowbrook Office Park, Fairport, NY 14450, as follows:

WITNESSETH

WHEREAS, the Grantor has heretofore granted to the Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in that certain First-Lien Security Agreement, dated as of June 12, 2006, between the Agent, the Grantor and the other parties thereto (the "Security Agreement")); and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Marks to the Grantor and to dissolve any and all Liens and encumbrances respecting the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor the security interest in the Marks set forth on Schedule A granted to the Agent by the Grantor pursuant to the Security Agreement, which security interest was duly recorded on June 20, 2006, at Reel 003334, Frame 0409 in the United States Patent and Trademark Office.
