TRADEMARK ASSIGNMENT

WHEREAS, Leach Company, Inc., a Wisconsin corporation having offices at 54 Park Place, Appleton, Wisconsin 54914 ("Leach"), owns the entire right, title and interest in and to the trademarks and trademark registrations set forth in *Exhibit A* attached hereto (hereinafter the trademarks and registrations are referred to collectively as the "Trademarks"); and

WHEREAS, Équipement Labrie Ltée, a Canadian corporation having offices at 175 Rte Du Pont, Saint-Nicolas (QC), G7A 2T3, Canada, ("Labrie") is desirous of acquiring all of Leach's right, title and interest in and to the Trademarks pursuant to an Asset Purchase Agreement made as of May 30, 2006, by and among Federal Signal Corporation, Leach Company, Inc., Leach North America Ltd. and Équipement Labrie Ltée contemplating the sale, transfer, assignment and conveyance to Labrie of certain assets of Leach Company, Inc. and Leach North America Ltd. associated with Leach's refuse business.

NOW THEREFORE, in consideration of these premises, the covenants and obligations set forth below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Leach has, and hereby does, sell, assign and transfer unto Labrie the entire right, title and interest in and to the Trademarks and any registration(s) issuing therefrom, together with the goodwill associated therewith, and the right to sue for, and recover for, any past infringements thereof, to be held and enjoyed by Labrie, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Leach had no sale and assignment of said Trademarks been made.

2. Leach shall, upon the request and at the expense of Labrie, execute any further documents reasonably required by Labrie to secure and enforce the rights granted to Labrie under this Assignment.

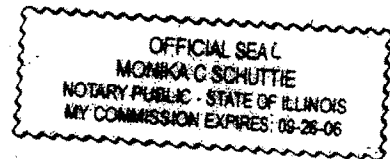
