**Background**

- A. The Assignor is the registered proprietor and beneficial owner of the registered trade marks, particulars of which are set out in the Schedule hereto ("Trade Marks").
- B. The Assignor has agreed to assign all rights in the Trade Marks together with the goodwill associated therewith to the Assignee.

**IT IS AGREED**

1. **Assignment**

- 1.1 In pursuance of the said agreement and in consideration of the sum of Ten Hong Kong Dollar (HK\$10) now paid by the Assignee to the Assignor (receipt of which is hereby acknowledged) the Assignor hereby assigns unto the Assignee all right, title and interest in the Trade Marks together with the goodwill associated therewith to hold the same unto the Assignee absolutely. The Assignment includes the right to sue for past infringements and to recover damages and other remedies for any such infringements.

2. **Assignor's obligations**

- 2.1 The Assignor shall execute any further document and do any such thing as the Assignee may require to enable the Assignee to become registered as proprietor of the Trade Marks and to secure the benefits of the rights hereby assigned.

3. **Law and Jurisdiction**


- 3.1 This Assignment shall be governed solely in accordance with laws of Hong Kong Special Administrative Region and the parties hereto expressly agree to submit to the exclusive jurisdiction of the Hong Kong Courts.






