TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows"

1. Assignor does hereby assign to Assignee, its successors, assigns, and legal representatives, the entire, full and exclusive right, title, and interest in and to the Trademarks, together with the good will of the business symbolized by the Trademarks and any applications and/or registrations therefor, and the right (but not the obligation) to assert the Trademarks and to collect for all past, present, and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties, and proceeds of infringement suits, and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur.

2. Assignor represents that Assignee is the successor to the portion of Assignor's ongoing and existing business to which the Trademarks pertain.

3. Assignor agrees to take all actions reasonably necessary to perfect Assignee's rights in the Trademarks, including executing such further documents as may be necessary or desirable.

4. This Agreement will benefit and bind the Parties and their respective successors, assigns, and licensees. The rights and duties of this Agreement shall be binding on the Parties and their respective successors, assigns, and licensees.


5. This Agreement contains the entire agreement between the Parties and supersedes any previous communications, representations, or agreements, verbal or written, relating to the subject matter of this Agreement. This Agreement may only be amended by a writing signed by both parties.


