## IP RIGHTS ASSIGNMENT

THIS IP RIGHTS ASSIGNMENT, effective as of January 1, 2006 (the "Effective Date"), is by and between SCOTT E. CONARD, individually ("Assignor"), and GATISH IP, LTD., a Texas limited partnership ("Assignee").

### RECITALS

WHEREAS, Assignor and Assignee are parties to that certain Agreement for Sale, dated the date hereof (the "Purchase Agreement"), providing for the purchase of certain IP Rights (including any and all goodwill associated therewith) (as more particularly described in Exhibit A attached hereto).

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Assignor and Assignee hereby agree as follows:

1. Capitalized Terms. Capitalized terms used but not defined herein shall have the meanings specified in the Purchase Agreement.


2. Assignment of IP Rights. Effective as of the Effective Date, Assignor hereby assigns and delivers to Assignee all of Assignor's right, title and interest in and to all of the IP Rights (including any and all goodwill associated therewith) as more particularly described on Exhibit A, attached hereto. Assignee hereby accepts the assignment of such IP Rights.

3. Terms of the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

4. Further Assurances. Each of the parties hereto shall, from time to time, at the request of the other party and at such other party's cost and expense, execute and deliver such other instruments of conveyance and transfer and do such further acts and things as may be reasonably required for the purpose of carrying out the provisions of this IP Assignment.

IN WITNESS WHEREOF, Assignor and Assignee have executed this IP Rights Assignment as of the Effective Date.


