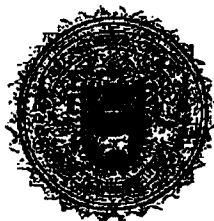

RESTATED CERTIFICATE OF INCORPORATION

Pursuant to the provisions of the Delaware General Corporation Law (the "DGCL"),  
Zonagen, Inc., a Delaware corporation (the "Corporation"), does hereby certify as follows:

1. Pursuant to a written consent of the Board of Directors of the Corporation (the  
"Board") executed on December 22, 2005, the Board adopted a resolution that the Restated  
Certificate of Incorporation of the Corporation be amended and that such amendment be  
submitted to the stockholders of the Corporation for their approval as follows:

Article I of the Restated Certificate of Incorporation is hereby amended to change the  
name of the Corporation so that it shall henceforth read in its entirety as follows:

"ARTICLE I

The name of the corporation is Repros Therapeutics, Inc."

2. At a meeting and vote of the stockholders held on May 2, 2006, a majority of the  
stockholders entitled to vote thereon approved said amendment to the Restated Certificate of
