TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of March 29, 2007, by **ALLIED CAPITAL CORPORATION** (“**Bank**”).

WITNESSETH:

WHEREAS, Bank and Huddle House, Inc., a Georgia corporation (“**Grantor**”), were parties to that certain Grant of Security Interest in Patent and Trademarks dated as of December 20, 2006 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Bank in all of its right, title and interest of certain trademarks (the “**Trademarks**”), including the Trademarks set forth on Schedule 1 hereto, the use thereof, the proceeds and products thereof and the goodwill of the business symbolized thereby (collectively, the “**Trademark Rights**”); and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on January 3, 2007, at Reel 3454, Frame 0138; and

WHEREAS, Grantor has requested that Bank release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Bank hereby releases its security interest in the Trademarks and the Trademark Rights.
