BUSINESS AGREEMENT

This Agreement is made and entered into as of January 11, 2006 by and between Air Waves Inc., 7787 Graphics Way, Lewis Center, Ohio 43065 (hereinafter referred to as the "the Company") and John Peppers and Rodney Ellison, D.b.a. as the following: Confederate Enterprises, Inc., Dixie Apparel Co., Rodco Rags Outfitters Western Wear, Hardcore Cowboy, Hardcore Cowgirl and Legends of the South, located at 1936 Williams Rd., Piedmont, AL, 36272 (hereinafter referred to as "Confederate Enterprises").

The Company is engaged in a business enterprise involving the creation of and application of works of art and design for use in producing screen printed apparel, heat transfers and digital imaging transfer paper.

Similarly, Confederate Enterprises has also been involved in a business enterprise involving the creation of and application of works of art and design for use in producing screen printed apparel and heat transfers.

The Company desires to purchase from Confederate Enterprises its entire customer list(s), art work, trade and brand names (hereafter referred to as "intellectual properties"). Confederate desires to sell to the Company its entire ownership of intellectual properties.

Furthermore, Confederate Enterprises currently owes the Company a sum of \$37,945.88 and desires to pay the Company in the form of manufacturing supplies, heat transfers and garment inventory in lieu of U.S. dollars. The Company desires to accommodate Confederate Enterprises in the manner proposed in this document.

Now, therefore, in consideration of the mutual promises, conditions, and covenants herein contained, and other good and valuable consideration, the receipt and sufficiency of which is by the parties hereby acknowledged, the Company and Confederate Enterprises agree as follows:

1. In consideration for Confederate Enterprises selling to the Company its entire customer list(s) and intellectual properties the Company will pay to Confederate Enterprises a sum of One U.S. Dollar (\$1.00) and a percentage of net sales generated by the Confederate Enterprise product lines extended over a period of three years, 2006, 2007 and 2008 (hereafter referred to as the "three year period"). The percentage of net sales will be paid in the form of royalty payments according to the schedule listed below:
 - 5% of Confederate Enterprises' net sales for its pre-print line.
 - 8% of Confederate Enterprises' net sales for its Hardcore Cowboy heat transfer line.
 - Royalty payments will be paid to Confederate Enterprises by the Company on a quarterly basis.
