RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated April 6th 2007 by LaSalle Business Credit, LLC, as hereinafter described;

WITNESSETH:

WHEREAS, LaSalle Business Credit, LLC (hereinafter referred to as the "Secured Party") with its mailing address at 135 South LaSalle Street, Chicago, Illinois 60603, and RM Acquisition Sub, LLC, a Delaware limited liability company (now known as Revell-Monogram, LLC) with its mailing address at 725 Landwehr Road, Northbrook, Illinois 60062 (the "Debtor") are parties to a certain Trademark Security Agreement recorded in the United States Patent and Trademark Office on February 27, 2003 at Reel 2660, Frame 0465 (the "Security Agreement"), pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations, and/or trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "Trademarks"); and

- (i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and
- (ii) All other property relating to the Trademarks as set forth in the Security Agreement; and
- (iii) All proceeds of the foregoing.
