ASSIGNMENT OF TRADEMARKS

This Assignment is binding on Company, its successors and assigns, and will inure to the benefit of the Purchaser, its successors and assigns. Nothing in this instrument, express or implied, is intended or shall be construed to confer upon, or give to, any person, corporation or entity other than Purchaser, its successors and assigns, any remedy or claim under or by reason of this instrument, or any terms, covenants or conditions hereof, and all the terms, covenants and conditions in this instrument shall be for the sole and exclusive benefit of Purchaser and its successors and assigns.
