RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS, (this "Release") is made as of December 22, 2003 ("Effective Date") among S&S Brands, Inc., a Delaware corporation, The Stop & Shop Supermarket Company, a Delaware corporation (each herein referred to as an "Intellectual Property Grantor"), and ING Bank, N.V. (the "Grantee"), as Issuing Bank and Facility Agent for the ratable benefit of itself and the other Lenders party to the Credit Facility dated as of March 3, 2003 (as amended, restated and otherwise modified from time to time, the "Facility Agreement") among the Grantors named therein and ING Bank N.V., as Issuing Bank and Facility Agent. All capitalized terms not defined in this Release shall have the meaning set forth in the Credit Agreement, the U.S. Security and Pledge Agreement or the Trademark Security Agreement, as applicable.

WHEREAS, pursuant to (i) the U.S. Security and Pledge Agreement dated as of March 5, 2003 (as amended, restated and otherwise modified from time to time, the "U.S. Security and Pledge Agreement") among the Grantors named therein and ING Bank N.V., as Facility Agent for the Secured Parties referred to therein (in such capacity, together with its successors in such capacity, the "Facility Agent"), and (ii) certain other Security Documents, including the Trademark Security Agreement (the "Trademark Security Agreement") among the Intellectual Property Grantors and the Grantee dated as of March 5, 2003, each Intellectual Property Grantor has secured its Secured Obligations by granting to the Facility Agent, for the benefit of the Secured Parties, a continuing security interest in the Intellectual Property Collateral of such Intellectual Property Grantor consisting of all rights, title and interest of such Intellectual Property Grantor in all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantors (collectively, the "Trademarks"), including, without limitation, the trademark registrations and the applications for trademark registration set forth on Schedule A attached hereto;

WHEREAS, certain documents ancillary to the U.S. Security and Pledge Agreement and the Trademark Security Agreement were recorded with the United States Patent and Trademark Office on March 5, 2003, at Reel 002613, Frame 0083; and


WHEREAS, Grantors have paid all of their outstanding indebtedness to the Grantee.


