TRADEMARK ASSIGNMENT

This Assignment will be construed under and governed by the laws of the State of Washington without reference to conflict of laws provisions thereof. This Assignment may be executed in counterparts, each of which shall be deemed an original, but such counterparts together shall constitute one and the same instrument.
