**TRADEMARK ASSIGNMENT**

This Trademark Assignment is effective as of March 15<sup>th</sup>, 2007, is made by TONY LUKE, INC., a Pennsylvania corporation having a principal business address at 1701 South 4<sup>th</sup> Street, Philadelphia, Pennsylvania 19148 (hereinafter "TLI"), to TL ENTERPRISES, LLC, a Pennsylvania limited liability company having a principal business address at 1701 South 4<sup>th</sup> Street, Philadelphia, Pennsylvania 19148 (hereinafter "COMPANY").

WHEREAS, TLI is the owner of the Trademarks **Tony Luke's®** and **TONY LUKE'S OLD PHILLY STYLE SANDWICH** (hereinafter, the "Marks") by virtue of its use of the Mark in commerce in connection providing products and service in the food, restaurant and quick service restaurant fields and other related products and services;

WHEREAS, TLI has received federal registrations for the Marks from the United States Patent and Trademark Office ("USPTO") and such registrations have been designated as U.S. Reg. Nos. 2,912,248 and 2,986,813, respectively;

WHEREAS, COMPANY has agreed to acquire any and all rights that TLI possesses in these Marks including the USPTO Registrations, together with the goodwill in connection with which the Marks are being used, and which is symbolized by the Marks, along with the right to recover damages and profits for past infringements thereof;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, TLI hereby assigns to COMPANY all right, title and interest in and to the Marks (and all Registrations and Applications filed in connection therewith) in the United States and throughout the entire world, together with (a) the goodwill of the business in connection with which the Marks are used and which is symbolized by the Marks; and (b) the right to recover for damages and profits for past infringements thereof;






