ASSIGNMENT OF SERVICE MARK

WHEREAS VTSLLC was converted to Velocity Technology Enterprises, Inc., a Delaware corporation ("VTE"), effective March 30, 2007; and



Upon Assignee's request, Assignor agrees that it will, without demanding further consideration therefor and at Assignee's cost, perform all reasonable, lawful, and just acts that may be necessary for carrying out this Assignment in full.
