2. The Assignor covenants to execute all such documents, forms and authorisations and depose to or swear any declarations or oaths as may be required by the Registrar of Trade Marks for

absolute vesting full right, title and interest in and to the Trade Marks, including the right to institute and maintain proceedings against any person in respect of acts of infringement of the Trade Marks prior to the date of the Assignment or hereafter.




