

1. I am President of OHP, Inc., and am authorized to execute this declaration.
2. OHP, Inc. has undergone a number of name changes and as the President of OHP, Inc., I am familiar with the previous names of the corporation.
3. On May 11, 1990, an assignment was recorded with the United States Patent and Trademark Office, at Reel/Frame 0710/0073, transferring ownership of Registration no: 1,478,248 from ICI Americas, Inc., to Olympic Chemical Co. See originally filed papers attached hereto as Exhibit "A."
4. This assignment contained a typographical error in the assignee's name.
5. The assignee was listed in the assignment as Olympic Chemical Co., but the corporation's correct name is Olympic Chemical Company, Inc.
6. At the time of the execution and recording of this assignment, there was not a legal entity using the name Olympic Chemical Co.
7. To the best of my knowledge, the corporation has never used Olympic Chemical Co., as its legal entity name.

8. The assignment that was recorded on May 11, 1990 should have transferred ownership of Registration No: 1,478,248 from ICI Americas, Inc., to Olympic Chemical Company, Inc.

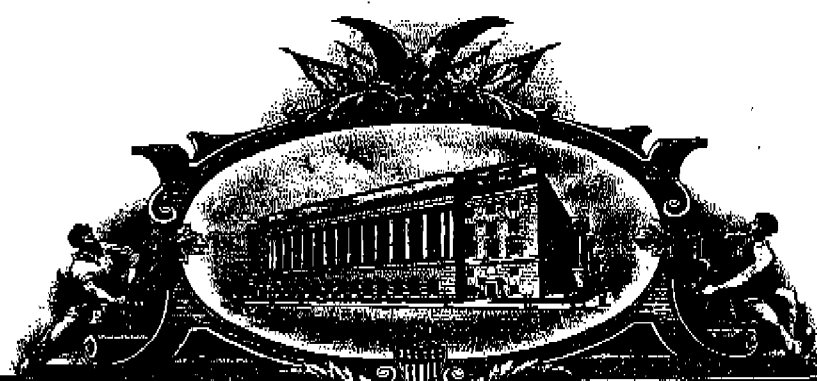
