Said Marks and registration therefor is to be held and enjoyed by ASSIGNEE for its own use and for its successors, assigns, and other legal representatives, the same as would have been held and enjoyed by ASSIGNOR had this Assignment not been made.

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this Assignment.


